Ensuring that the Authority is making as much information as possible available to the public reflects both good governance and a commitment to transparency but also reduces the time taken to respond to freedom of information requests.

5 Background and Options

- 5.1 The Freedom of Information Act 2000 requires public authorities to maintain a publication scheme which sets out the information which they will routinely publish and how it can be accessed. On implementation of the Act the Information Commissioner provided template schemes for different types of public body, which have developed to provide a framework for the publication of information allowing members of the public to more easily access the information they are looking for. Following the implementation of the Act the coalition government from 2010 developed additional requirements for local authorities in particular in the Code of Transparency which among other things requires the publication of details of all payments over £250 by principal councils.
- 5.2 The Authority has long had a commitment to transparency and deals with as much of its business in public as possible. Over the last two years additional information has been published on the website and the structure of the website has been altered in order to make information more accessible. This is an ongoing process and further work is planned to improve the design and layout of the site. However, the provision of additional information in an easily accessible form means that the current Publication Scheme has become outdated and it is necessary for it to be updated to reflect the reality of the situation. An updated scheme reflecting the current position is presented for approval at Appendix A.
